

**MINUTES OF THE MEETING ON FREE SALE OF POL/HSD HELD IN THE
OFFICE CHAMBER OF DEPUTY COMMISSIONER, AIZAWL ON 5.7.2022 AT
1:00 PM**

The meeting was chaired by Dr Lalhriatzuali Ralte IAS, Deputy Commissioner, Aizawl District and members present in the meeting is appended as Annexure.

The chairman welcomed the members and invited Pu Rodingliana Chawngthu, Sr. SP Traffic to explain problems being faced in traffic maintenance due to free sale of POL/HSD by filling stations. The meeting further discussed various issues regarding current situation of fuel shortage and related problems. Decisions of the meeting were recorded in the following points:

1. **Prior Intimation to Sr. SP Traffic:** The meeting was informed that members of All Mizoram Petroleum Dealer Association (AMPEDA) within Aizawl Municipal Area failed to give prior intimation to Sr. SP Traffic before free sale of fuel to the public, which in turn caused problems to the concerned office in traffic management. The meeting decided that all members of AMPEDA within Aizawl shall give intimation well in advance before free-sale of POL. Prior intimation shall be given to the Deputy Commissioner Aizawl and Sr. SP Traffic Control Room (2322307/2313061/9366553559).
2. **Time restricted for free-sale:** The Meeting decided that free-sale of POL/HSD to the public will not be permitted during peak traffic hours viz 7:00 a.m to 10:00 am and 4:00 pm to 6:00 pm until normalcy in supply of POL/HSD is restored. Sr. SP Traffic will ensure that no queue is lined during this period.
3. **Enforcement of traffic rules :** Office of the Sr. Superintendent of Police, Traffic, Aizawl will issue Public Notice regarding observance of Traffic Rules, driving manners and etiquettes. Further, the sequence of vehicles awaiting their turn to be attended at Filling stations should only be in a single line. Sr. SP Traffic will ensure compliance and AMPEDA will give information to its members .
4. Directorate of Food, Civil Supplies & Consumer Affairs may issue regular and timely notice to the public with information on the POL Stock position of the state/District, expected consignments and their arrival as well as advisories on pilferage, black marketing and panic buying for assurance of the general public

The meeting concluded with a vote of thanks from the chair.


